

1. The tender must be properly sealed and duly marked "**Tender for LIBRARY BOOKS AND JOURNALS due on 18.2.2019**" under register cover (if posted) addressed to the Principal, H P Govt. Dental College & Hospital Shimla by designation and not by name.
2. For all the items, reputed Publishers or their authorized distributors with authority letter from the original manufacturer(s) / Publishers , can submit their tenders.

3. In all cases of the imported Journals , the country of Publisher(s) and units of subscription/ measurements/ value in Indian currency must be prominently stated as on the date of opening of the tender .
4. The original catalogue / literature of publisher should be attached with the tender and **no photocopy will be entertained**. All document of the tender (every page) should be duly stamped and signed.
5. Books and Journals should be supplied strictly as per list attached. **NO REPRINT** of any Journals will be accepted.
6. The tenderer must have at least 10 years experience in the field of Publishing / distribution/ and distributorship of the journals. Bidders will have to submit detail of supplies made to various institutions during the **preceeding10 years if any** .
7. Rates should be quoted separately for BACK VOLUMES and Current Volumes as strictly as per the serial Number of the list attached along with Original tender documents .
8. The **minimum delivery period and the validity of offer/ conversion rate validity** should be specified.
9. All quotations/tender will be deemed FOR destination inclusive of packing and forwarding charges unless and other wise specified in the tender/ quotations.
10. The tenderers shall dispatch journals “FREIGHT PAID” in all cases where offer is FOR destination. In the event of their failure to do so, a penalty of 10% shall be charged from the concerned firm on the amount paid as freight by the indenting officer in this behalf.
11. The tenderer shall have to pay demurrage charges etc. if incurred on account of delayed receipt of Journals other wise the same will be recovered from their bill.
12. The tenderer will have to execute supplies as per order(s) satisfactorily with in stipulated period of 60 days failing which undersigned reserves the right to purchase Library Books and Journals from other sources at the risk of the supplier and in that event the EMD deposited by the firm can be forfeited.
13. **The inspection of the Library Books and journals will be carried out by the Library Committee of the institution at destination** and rejected journals shall have to be collected by the suppliers with in 10 days of dispatch of advice from the undersigned failing which books and journals will lie at the risk of the supplier.
14. The rates approved on the basis of tender for Journals as per list attached shall be applicable for a period of **one year from the date of its approval**. The successful tenderer shall have to sign an agreement containing such terms and conditions as may be defined by the Principal, HP GDC Shimla for entering into Rate Contract on the stamp paper of Rs.50/-. The agreement should be duly attested by the executive magistrate. **No claim of difference amount of rates on the date of supplies of journals shall be entertained**.
15. The EMD or SECURITY DEPOSITS in respect of supply of journals will be refunded after the satisfactory execution of the supply.

16. Any **omission/correction/cutting** in filling the columns of unit and rates shall debar a quotation from being considered and the tender should be typed neatly.
17. The tender will be regarded as constituting an offer or offers open to acceptance on whole part(s).

18. **Tenders without requisite certificates / authority letter/ documents/literature/catalogue and EMD shall be rejected straight way.**

19. Undersigned reserves the **right to accept or reject any or all** the tenders without assigning any reasons.

21. In the event of the any of the copies of the said Books , periodicals and journals being lost in transit or in the event of supplier failing to supply any such copies after their publication for any reason what-so-ever, the supplier shall replace all such copies as may have been lost in the transit or as the case may be , supplied to the Govt. without any extra charges on receipt of intimation in this behalf .
22. If the Govt. decides not to subscribe to any or more of the aforesaid Books , periodicals and journals, the Govt. shall give to the supplier one month's notice in the case of Indian Books and Journals / Periodicals and One month notice in case of Foreign Books , Journals / Periodicals in writing, intimating to the supplier such intention of the Govt. and supplier shall on the expiry of the said notice refund to the Government proportionate amount of the subscription for the period which may remain unexpired.
23. The Government shall be entitled to cancel the supply order on one month notice in writing to the suppliers without assigning any reason what so ever and on such termination, the suppliers shall refund to the Government all the proportionate amounts of the subscription for the period which may remain unexpired.
24. In the any question, dispute or differences arising under or out or in connection with these presents or touching or dealing with, operation or effect thereof or of any matter contained therein or as to the rights, duties or liabilities of the parties hereto respectively, or otherwise, however in connection with these presents(except as to matters the decision of which here before specially provided for) the same shall be referred to the sole arbitrator of any person appointed by the Addl Chief Secretary(Health) to the Government of Himachal Pradesh Administration dealing with the contract at the time of such appointment. It will be no objection to any such appointment that the person appointed is a Government servant, that he had to deal with the matter to which these presents relate, and in the course of his duties as such Government servant he has expressed views on all

or any of the matters in dispute or differences. The award of the arbitrator so appointed shall be final and binding on the parties to these presents. 31. The Price comparison shall be made on the basis of discount offered on publisher's printed price. Separate price comparison shall be done for Indian and Foreign Books and Journals. The discount shall be quoted in PERCENTAGE Only all the prices shall be F.O.R. destination at Library of HP GDC Shimla.
32. Payments made consequent to any notified change in GST/ sales Tax and other statutory levies (both increase or decrease) shall be to the purchaser's account. For such claims of variation, the bidders shall have to produce the Govt. Notifications as documentary evidence. Price variation due to any other cause shall be on bidders account.
33. The firm has to provide the break-up of expenditure of different quoted journals as total expenditure clearly for the whole items.
34. Excise / custom duty / VAT / Entry Tax and any other levy / surcharges in any shape or by whatever nomenclature may be included in the amount quoted unless it is specifically mentioned separately.
35. The Purchaser reserves the right to vary the quantities and / or services.
36. Prior to the expiry of the period of validity, the Purchaser will notify the finally selected bidders in writing by registered post or by cable fax, to be confirmed in writing by registered letter or by hand in person, that its bid has been accepted. If need for the extension of the bid validity period arises, it should be extended by mutual consent/ agreement. Before the award of the contract the college may hold negotiations with the

 39. The supplier shall indemnify the Purchaser against all third party claims of infringement of patent, copy right, trademark, license of industrial design rights, software piracy arising from use of the store / goods or any part thereof in the purchaser's country.
 40. The purchaser may without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, terminate the contract in whole or in part:-
 - i) If the supplier fails to deliver the articles / Books and Journals with in the time period(s) specified in the contract.
 - ii) If the supplier fails to perform any other obligation(s) under the contract.
 41. The purchaser may at any time terminate the contract by giving written notice to the supplier without compensation to the supplier, if the supplier becomes bankrupts or otherwise insolvent (which shall be breach of the contract on the part of the supplier), provided such termination will not prejudice or effect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.
