Order U/S 34 of the Disaster Management Act, 2005

Whereas, the Chief Secretary-cum-Chairperson, State Executive Committee, Himachal Pradesh has after considering the unprecedented surge in COVID-19 cases, high positivity rate and in order to break the transmission chain of COVID-19 virus, issued advisory for the effective management of COVID-19 vide No. Rev (DMC) (C) 20-2/2021-COVID-III dated 04-08-2021 in the state till further orders.

And Whereas, inspite of the various restrictions imposed by the undersigned to control the spread of virus and mitigate the various risks related to the virus, there has been massive crowds in market places, violating the norms of social distancing which is matter of concern. The situation demands more effective implementation of appropriate COVID-19 protocol in crowded places i.e. shops, malls, markets, markets complexes, weekly markets, restaurants & bars, mandis, bus stations, railway platforms/ stations, public parks & gardens, gymnasiums banquet halls/ marriage halls, stadia/ sports complexes as well as at all areas identified as hotspots for transmission of COVID-19 virus.

And therefore, in continuation to this office order No. SML-ADM (L&O)/COVID-19-1544-1567 dated 23-06-2021, No. SML-ADM (L&O)/COVID-19-1658-83 dated 03-07-2021, No. SML-ADM (L&O)/COVID-19-1718-40 dated 07-07-2021, and No. SML-ADM (L&O)/COVID-19-1897-1918 dated 24-07-2021, I, Aditya Negi, IAS, Chairman, District Disaster Management Authority-cum-District Magistrate Shimla, exercising the powers conferred in me under Section 34 of the Disaster Management Act, 2005, do hereby order the following in the public interest:-



1. "NO MASK-NO SERVICE" policy of the state government will be followed strictly by all. Only the people using face cover/ mask will be allowed to board public/ private transport such as train, buses, taxis etc. Similar restriction will apply to enter hospitals, colleges, Govt. offices or private establishments/ shops etc. for availing the services/ goods.
2. There should be continuous focus on the five-fold strategy for effective management of COVID-19 i.e. Test-Track-Treat-Vaccination and adherence to COVID appropriate behaviour.

organization/ offices shall be responsible for implementation of this order and all protocol/ SOPs related to COVID-19 within their offices/ organizations.

4. All persons intending to visit state for tourism related activities are advised to carry their COVID-19 Vaccine Certificate (single or both doses) or a negative RT-PCR test report issued not earlier than 72 hours.

It shall be the responsibility of the Superintendent of Police, Shimla concerned Sub-Divisional Magistrates and all representatives of concerned PRIs/ ULBs to implement these orders within their jurisdiction.

This order shall come into force with immediate effect in the entire territorial jurisdiction of Shimla District and will remain in force till further order and all other restrictions and relaxations shall remain same as per previous order dated 23-06-2021, 07-07-2021 and 24-07-2021.

Violation of the order shall attract provisions of Section 51 to 60 of Disaster Management Act, 2005, Section 188, 289 & 270 of IPC and Section 111, 114 and 115 of HP Police Act, 2007 and the violators shall be prosecuted accordingly.
